

Declaration of Candidacy Application for Rancho Bernardo Elections for:

1. **Rancho Bernardo Community Council** (Representing and Elected from a Specific District)
2. **Rancho Bernardo Planning Board** (Representing and Elected from a Specific District)
3. **Rancho Bernardo Recreation Council** (Representing and Elected from the RB Community at Large)

Who is Eligible: Candidates must be residents of Rancho Bernardo and at least 18 years old. The residency requirement is 30 days, and for the Community Council and Planning Board - it needs to be in their specific district.

Area Represented: Recreation Council members are elected at large by all residents of the Rancho Bernardo Community. Community Council Members and Planning Board Members are elected by the specific district in which they live. (See Descriptions of Districts on reverse side.)

Steps to Apply: Candidates must complete this Declaration of Candidacy Application and submit it to the Election Committee per the instructions below. Candidate's name will appear on ballot as printed below in an order on the ballot to be determined by a drawn lot. If a picture of the candidate is attached, candidate agrees that the picture may be published in the local newspaper, newsletter or other election materials.
